#### MEDICINE AT THE SERVICE OF THE HUMAN PERSON Timothy J. Furlan, PhD, MBE

This presentation will outline how medicine should serve and respect the good of the human person. It will discuss the implications of the secularization of medicine and medical ethics upon the treatment of the human person and evaluate how contemporary medicine undermines the good of the human person, citing specific examples.

### THE MENTAL HEALTH CRISIS FOR CHILDREN IN LIGHT OF COVID-19 AND BEYOND

This presentation will evaluate the mental health crisis and suicidal ideation, which has preceded the COVID pandemic and has only been exacerbated by the pandemic, particularly for children and adolescents. It will assess varying strategies for health care professionals in collaboration with families and schools to address the causes of stressors that have increased the struggles with suicide ideation, hopelessness, anxiety, and depression.

### HIDDEN IN PLAIN SIGHT: HUMAN TRAFFICKING IN OUR MIDST

This presentation will discuss the tragedy of human trafficking and the role of medical professionals in addressing this crisis in places where medicine and trafficking intersect. It will propose effective response to victims of trafficking who present to medical professionals in the clinical context.

### THE ROLE OF PUBLIC HEALTH IN TRADITIONAL MEDICINE

This panel discussion will address the relationship between public health and the practice of medicine in light of ethics. ## VOCATION OF THE HEALTH CARE PROFESSIONAL Kristin M. Collier, MD, FACP

This presentation will focus on the need for the practice of virtue for all health care professionals. It will identify the essential virtues for the health care worker, analyze some of the root causes of burnout among health care professionals, and explain how saintly physicians such as St. Giuseppi Moscatti and St. Gianna Molla serve as models of the virtues needed for patient care.

### ST. JOHN PAUL II ON THE ROLE OF TRUTH AND FREEDOM IN MEDICINE

This presentation will discuss the relationship between truth and freedom in the theology of St. John Paul II and the implications of this relationship for the practice of medicine. It will determine how the correlation between freedom and truth affects the development of the conscience of the individual health care professional.
