#### Objectives:

- Discuss the unique aspects of providing health care to women.
- Propose an integral view of the human person as essential for comprehensive and holistic medical care for women.
- Identify medical care that respects the unique ways women bring life, love, and their feminine genius into the world.
- Describe medical care that respects the unique ways women bring life, love, and their feminine genius into the world.
- Appraise the unique approaches of Catholic hospitals and Catholic health care providers in offering care for women that affirms the unique dignity and genius of women.
- Compare a Christian anthropology with a secular anthropology of humans.
- Discuss the relationship between the definition of anthropology and its relationship to the practice of ethical medicine.
- Discuss what it means to speak of the dignity of the human person and how this dignity impacts medical care.
- Cite examples of how varying anthropologies affect the practice of medicine.
- Identify the key ethical principles that guide decision making when patients are no longer aggressively pursuing curative measures.
- Cite case examples that apply ethical principles in patients pursuing palliative care.
- Discuss the role of palliative care in medicine today.
- Describe the benefits of palliative care and hospice for the patient and his/her family.
- Discuss the basic principles of Catholic social doctrine.
- Discuss how greater focus on the dignity of the human person, care for the common good, solidarity, and subsidiarity affects health care.
- Describe how patient care is improved by the commitment to principles of Catholic social doctrine and how such care will be distinctive

in clinical practice.

- Identify how mental health impacts medical care, clinical encounters, and outcomes for patients and practitioners.
- Discuss the causes and factors that have led to the development of the mental health crisis in the United States.
- Appraise how Catholic hospitals and health care providers offer unique perspective in addressing the current mental crisis in light of Christian anthropology.
- Describe interventions utilized in fertility awareness-based methods (FABMs) and in restorative reproductive women's health care, which assist in the flourishing of the human person.
- Describe how FABMs can be effective in helping couples achieve pregnancy.
- Identify medically successful alternatives to artificial reproductive technologies.
- Discuss ethical issues regarding artificial reproductive technologies.
