Objectives:

- Describe the origins of transhumanism and its impact on advancements in science and medicine.
- Identify criteria to guide scientists and clinicians in the ethical use of transhumanist technologies.
- Assess how human enhancement technologies undermine the full flourishing of the human person and the practice of ethical medicine
- Distinguish between living will and medical power of attorney and describe the ethical concerns arising from their use or lack thereof.
- Indicate how DNR and POLST impacts the course of treatment and care offered to patients.
- Discuss the principle of free and informed consent and its relevance to advance planning documents
- Discuss the basic principles of social doctrine for the Church.
- Explain how greater focus on the dignity of the human person, care for the common good, solidarity, and subsidiarity affects health care.
- Discuss how patient care is improved by the commitment to the principles of Catholic social doctrine and the works of mercy and how such care will be distinctive in clinical practice.
- Define the unique understanding of human dignity that influences a Catholic approach to health care.
- Differentiate between the anthropology that undergirds a Catholic approach to end of life care in contrast with implications of a secular anthropology.

- Discuss the present challenges to preserving the dignity of the human person at the end of life in terms of culture, developments in healthcare, and public policy.
- Describe IVF and the foundational rationale for why IVF is a fundamental life issue.
- Identify the ethical and health concerns related to IVF.
- Identify medically successful alternatives to IVF.
- Discuss the causes and factors that have led to the development of the mental health crisis for children and teenagers in the United States.
- Appraise the adverse effect of the use of technology and how social media has worsened the mental health crisis.
- Assess varying strategies for health care professionals in collaboration with families and schools to address the causes of stressors that have increased the struggles with suicide ideation, hopelessness, anxiety, and depression.
