## **Objectives:**

- Explain the unique relationship of the health care provider with his or her patients.
- Identify the essential virtues necessary for a health care professional.
- Discuss the challenges a health care professional experiences in the current cultural environment.
- Consider what it means to speak of the dignity of the human person and how this dignity impacts our understanding of freedom, conscience, and integral medical care.
- Differentiate between an approach to health care that focuses on the primacy of the dignity of the human person in contrast with an approach that focuses on medicine's notion of autonomy.
- Describe how medicine is entrusted with the responsibility to serve the patient in all their dimensions and to ensure that the standards of care are oriented to their full flourishing as a person.
- Outline guidance for health care professionals to act in accordance with the dictates of their conscience as they fulfill their responsibility to be stewards of the life or lives entrusted to them.
- Discuss the meaning and purpose of suffering and how to help patients mature through suffering.
- Consider and define compassion in the care of patients and their families.
- Explore the role of hope and how to foster hope appropriately within the patients and families served.
- Describe the unique faith-based understanding of suffering, hope anthropology, and death and the implications this has for ethical
  care of the sick and their families.
- Explain the role of the sacraments and prayer as part of the essential spiritual care of the sick.

- Outline ways in which health care providers can support the administration of the sacraments and the offering of prayer as part of
  the spiritual care of the sick.
- Explain medical interventions that may be made on behalf of some populations that experience disability.
- Appraise case studies that offer practical examples of medical and spiritual care and support for the patients and their families.
- Describe how medical professionals may navigate difficult conversations with medical, social, and ethical implications.
- Outline and discuss the ethics of the varying operations, treatments, and medications during pregnancy related complications.
- Identify misconceptions regarding the types of medical interventions that are ethically permissible to treat pregnant women.
- Review case studies that highlight the morally and medically appropriate interventions available to the provider and the patient in light of pregnancy-related and perinatal complications.
